**Sub: - Selection for the post of Chief Vigilance Inspector/S&T in Level-7
(7th CPC) in Vigilance Organization of NER/GKP.**

Applications are hereby invited from the eligible candidates in order to fill up the following **01 (one)** ex-cadre post in the Vigilance Organization of NER / Gorakhpur, (proforma enclosed) :-

S.No.	Post and Pay	Number of Vacancies
1.	Chief Vigilance Inspector / S&T Level-7, in Pay Matrix of 7 th CPC	01

2. Eligibility and Terms & Conditions:

- (i) **Candidates must have completed minimum five (05) years of continuous service in Railways.**
- (ii) Candidates must have at least 5 years of railways service left as on date of notification.
- (iii) Staff should be working in Level-6 or Level-7 of Pay Matrix in S&T Department as SSE/JE on a regular basis.
- (iv) **Candidate must have sound integrity, and should not be figuring in any current Vigilance/SPE/DAR, 3 RP (UP) Act case. NO penalty (Major or Minor) should have been imposed on them in any past vigilance case.**
- (v) The candidates, who have already completed their tenure in Vigilance Organization of Zonal Railway / Production Units / Railway Board as Investigating Inspector (Vigilance) / Vigilance Inspector, are not eligible.

- (vi) The staff/supervisors serving on deputation in Railway PSUs may apply, however their application should be forwarded by the respective Cadre Controlling Authority of their parent Railway.
- (vii) Working knowledge of Computers is mandatory.
- (viii) Application of only those candidates, who can be spared on selection, may be forwarded. It may be noted that **it will be compulsory to relieve the candidate after selection.**
- (ix) Vigilance is an ex-cadre unit. Therefore, staff selected for posting in vigilance department will continue to maintain their lien and seniority in their parent department/cadre.
- (x) Though the normal tenure of CVI will be four (04) years, which may be extended for further period in stages depending upon the individual's performance and integrity. The Vigilance Inspector is liable to be repatriated to their parent department at any time, short of completion of the specified tenure, without assigning any reason.
- (xi) Applications should be submitted in the proforma enclosed, complete in all respects and duly signed by the Applicant. Submission of false or misleading information by the candidate would lead to D&AR action.
- (xii) Applications should be submitted through proper channel and after obtaining necessary approvals.
- (xiii) Number of vacancies may change as per requirement.

3. Method of Selection:-

- i. In terms of Indian Railway Vigilance Manual (IRVM) – 2018, Chapter-VIII, Para 821.5, the normal establishment rules applicable to regular selection post need not to be applied in the case of selection of Vigilance Inspector.
- ii. All the applications received upto the last date will be screened and those candidates who are found suitable would be subjected to written test and a Vigilance Aptitude and Computer knowledge test which would be conducted in the form of viva-voce. The distribution of marks for selection is stated below:-

S.No.	Criteria	Distribution of marks
1	Written Examination	50
2	Vigilance Aptitude & Computer Knowledge Test	30
3	APARs for the last 3 years (O/S:05, V.Good:04, Good:03 & Average:02)	15
4	Academic Qualification (Engg. Degree/PG:05, Diploma in Engg./ Graduate:03 & Under Graduate:01)	05

Note:- Candidates, who have obtained at least 60% marks in the written examination, would be called for appearing in the Vigilance Aptitude & Computer knowledge test and those, who are securing 60% of marks including Written test, Vigilance aptitude, Service record (APARs) and Academic qualification in aggregate, would be eligible for empanelment.

4. **Syllabus for the Written test:-**

- (i) General knowledge of rules including knowledge of Discipline and Appeal Rules-1968.
- (ii) Questions related to the concerned discipline (Signaling and Telecom).
- (iii) Writing of self-contained investigation report on a case including framing of draft chargesheet.
- (iv) General Knowledge and I.Q.
- (v) Questions related to Rajbhasha.

5. The applications should reach the office of General Manager / Vigilance, North Eastern Railway Gorakhpur-273012 latest by **26.08.2022** duly forwarded through proper channel along with attested copies of APARs for the year 2019-20, 2020-21 & 2021-22. This notification is also available on Zonal Railway website ner.indianrailways.gov.in —> About us —> Departments —> Vigilance —> Selections, from where it can be downloaded readily.

6. The selected candidates will be required to join the Vigilance Organization immediately. The candidates once selected will not be allowed to withdraw their candidature.

7. The date of written test will be intimated to eligible candidates later.

8. **The last date of receipt of application in this office would be 26.08.2022.** Applications received after the prescribed date or without proper forwarding through proper channel/ Competent Authority would not be entertained under any circumstances.

Applications of those employees, who have not undergone any penalty in a Vigilance / SPE case during their service period, and of the employees who have not undergone any penalty under DAR in the last 3 years, should only be forwarded.

Wide publicity to this notice may please be given among the staff and this should be displayed in all subordinate offices at conspicuous places for information and wide circulation amongst staff. Copy of circulation of notice may please be sent to this office for record.
