Sub- e-RD-Registration of Demand for wagons electronically through Web.
Ref: This Rly's Rates Circular (Goods) No.83 of 2014 & This Rly's Rates
Circular (Goods) No. 90 of 2014.

Please refer to Annexure-1 of this Railway's Rates Circular (Goods) No.83 of 2014 under reference which prescribes the procedure for submission and sanction of Sponsored traffic. Vide Board's letter No. 2008/TT-III/1/1 dated 30.07.2014. Preferential Traffic Order GO No. 87 has been issued.

A clarification has been sought regarding designated Railway authority for approving the programmed traffic of 'Food grains and 'Fertilizers' in the e-RD.

It is advised that designated Railway authority for approving all type of Programmed Traffic in the e-RD will be as per Preferential Traffic Order issued by this railway's Rates Circular (Goods) from time to time.3

In view of the above, the designated railway authority indicated against item No. 2.0, 3.1 and 3.2 of Para 3.0 of Annexure-1 of the circular under reference, may be modified as under :

	Commodity	Designated Railway Authority
2.0	Food grains	Zonal Railway/ Railway Board
3.0	Fertilisers	
3.1	Fertiliser – Domestic	Zonal Railway
3.2	Fertiliser – Imported	Zonal Railway
