Rates Circular (Coaching) No. 07 of 2015
(Case C/72/1/3/2/2/135/Pt.III/RC)

Sub. - Concession based ticketing facility including online ticketing for the physically challenged persons using Photo Identity Card.

With a view to facilitating physically challenged persons to avail concessional tickets across counters as well as through internet, a pilot project on Northern Railway has been launched for concession based ticketing through counters as well as internet for the physically challenged persons using Photo Identity Card. Under this scheme, the physically challenged persons can book concessional reserved tickets across PRS counters and internet and concessional unreserved tickets across UTS counters throughout the country on the authority of Photo Identity Card issued by the Railways. In the pilot phase, Northern Railway is the card issuing zone which can issue cards on the basis of Concession Certificate issued by the Government Hospital/Clinic/institutions as the case may be, lying in the jurisdiction of Northern Railway.

2. A copy of Photo Identity Card may be retained on PRS/UTS counters. The passenger will have to carry the Photo Identity Card in original during the journey and shall be required to produce the same for verification during on-board/off-board checking. The details of any one of the ten valid ID proof of the escort should be indicated while booking concessional reserved tickets through internet and PRS counters which will be fed in the system and the same must be carried in original during the journey for onboard/offboard verification.

3. All Divisions are requested to ensure effective implementation of the scheme. Staff concerned to please note and act accordingly.
