(Case No. C/407/Railway Terminal /ware house/2001/Pt.II)

Sub- Amendment No. 2 to MOU dated 22.04.2013 signed amongst Ministry of Railways, Central Warehousing Corporation (CWC) and Central Railside Warehouse Company Ltd.(CRWC).

1.0 Please refer to case No.C/407/Rly./Terminal/Warehouse/2001/Pt.II dated 12.06.2013 regarding tripartite MOU signed on 22.04.2013 amongst Ministry of Railways, Central Warehousing Corporation (CWC) and Central Railside Warehouse Company Ltd. (CRWC).

2.0 It has been decided to make amendments in the Para 8.0 of the aforesaid MoU. The amended Para 8.0 is as under:

“Para 8.0 And Whereas, in order to utilize the experience and expertise of CWC in providing warehousing facilities. MOR and CWC reached an understanding for development of warehousing complexes near 22 railway terminals as per enclosed list (Appendix-I(A) & I (B) to provide better service through total logistic solution to Rail users and to attract additional traffic & revenue to Railways and CWC. However, the list was provisional and it was mutually kept open for Railways and CWC to develop alternative locations wherever it was not found feasible to develop the integrated warehousing complexes as per the list.

In addition to the above, Ministry of Railways and CRWC have reached an understanding for development of additional 10 RWCs with Temperature Controlled storages at ten locations as per enclosed list at Appendix-I(C). This list is also provisional and is kept open to develop RWCs at alternate locations as mutually agreed.”

2.1 The above changes in the MOU will come into force with immediate effect.
