Sub: Revision of rates on Mumbai Port Trust Railway.

Sanction of the Central Government is hereby communicated for the revision of siding charges in respect of Mumbai Port Trust Railway as per the details given below.

(i) Haulage Charges on through traffic	Rs. 1835/- per 8 wheeler wagons
(ii) Siding Charge on foreign railway traffic	Rs. 425/- per 8 wheeler wagons
(iii) <u>Rebooking Charges:</u> At Owner's Risk	Rs. 2275/- per 8 wheeler wagons
At Railway Risk	Rs. 2730/- per 8 wheeler wagons
(iv) Infringement Charges.	Rs. 3710/- per 8 wheeler wagons

These chares for 4-wheeler wagon will be 0.40 times of the charges of the 8 wheeler wagon and will be rounded off to the next higher multiple of Rupees five.

The revised charges sanctioned above may be given effect from a suitable date after giving proper notice to the public and to the other Railways. These rates will remain applicable till further revision. A copy of your detailed notification may be endorsed to the Ministry of Raiways.
