Sub- Rationalization of rates for parcel traffic for the purpose of charging of freight for parcel & luggage traffic by South Central Railway.

Extract of Central Railway's Rates Branch circular No.14 of 2015 (Parcel) dt. 26.5.2015 on the subject matter is reproduced below:-

The list of trains kunder Rajdhani Parcel Services. (Scale-R) , Premier Parcel Service(Scale-P) and Standard Parcel Service (Scale-S) for booking of Parcel and Luggage (non-leased) notified by South Central Railway, effective from 01.06.2015 is enclosed herewith.

It is requested to circulate the same to the stations over your zone and ensure to charge the parcel and luggage correctly as per the category of the train service notified vide above reference.

The revised rationalized rates structure will be **with effect from 01.06.2015.**

All the Divisions should take immediate steps and ensure strict compliance of these instructions by all concerned to prevent any possibility of leakage of railway revenue
