Sub: Rationalization of rate structure for booking of non leased parcel & luggage traffic effective from 01.06.2015.

Extract of S. Railway's Rates circular No.C.441/11/10/utilization /2014-15 dated 29.05/2015 subject matter is reproduced below:-

Vide the above referred ARN, classification of scale for charging of non-leased parcels and luggages w.e.f.01.05.2014 were notified for the trains originating from Southern Railway based on its utilization.

The revised classification of scales for non-leased parcels and luggages w.e.f. 01.06.2015 for trains originating from Southern Railway are given in annexures as follows-

- Annexure-I - Mail/Express trains (06 pages)
Annexure-II - Passenger trains (07 pages)

Apart from the trains notified in the annexure, any new/special trains introduced later than 01.06.2015, until next revision of classification of scale for charging of non-leased parcels and luggages, the said parcels and luggage scale may be charged as detailed below:-

1	Newly introduced regular Mail/Exp. Trains	Scale-P	Scale-L
2	Newly introduced regular Ordinary Passenger trains	Scale-S	Scale-S
3	Summer Special, Puja Special, X-MAS Special and Holiday Special trains.	Minimum Scale-P	Scale-L
