Sub: Revision of Siding charge in respect of Bajaj Hindustan Ltd. Siding, Paliyakalan.

Name of Siding – BHLS

Serving Station – PLK

Notified vide Rates Circular No. 09 of 2014 dated 25-02-2014 are hereby cancelled and withdrawn with immediate effect. The period wise siding shunting charge leviable from 01.07.2013 to 30.06.2014 are now finally revised as under :-

Note –

- i. The siding charge will be collected locally and will not shown on invoice of Railway Receipt.
- ii. The siding charge will be levied for each round trip of engine separately both on loaded/empty wagon placed/withdrawn from the siding.
- iii. For shunting performed, if any, by the Railway engine beyond transfer Line, a separate shunting charge per engine hour or part of an hour notified time to time is to be levied in addition to the siding charge.
- iv. Service Tax at the rate notified by this Railway's under various circulars till date shall be collected additionally.
