**NORTH EASTERN RAILWAY**  
**RATES CIRCULAR (GENERAL) NO. 6 OF 2015**  
**(CASE NO.- C/431/0/1/Pt.IX/G-2/RBS/I)**

**Sub:-** Modification in the jurisdiction of N. Railway & N.E.Railway with formation of Zonal interchange point SPC between N.Railway & N.E.Railway in place of SCC.

**Ref:-** This Railway's Rate Circular (General) No.5 of 2015 dt.28.8.15.

Vide above referred notification the jurisdiction of Lucknow division of North Eastern Railway has been extended from Km 84.474 to Km 80.300 including Sitapur Cantt (SCC), Sitapur Kutchery Halt (STRK) and Sitapur City Thompsonganj Siding (TSG).

The boundary between North Eastern Railway and Northern Railway is shifted from Km 84.474 to Km 80.300 towards Sitapur City Jn. The Zonal Railways interchange point between N. Railway and N.E.Railway will be Sitapur City Jn. ( SPC) in place of existing interchange point Sitapur Cantt (SCC) w.e.f. 01.09.2015.


