Railway Board has further reviewed the operation of Bharat Darshan Trains and decided as under:-

- (i) The Railway charging principle and passenger tariff will continue to be the same as conveyed vide **This Railway's Rates Circular(Chg.) No.55/2014 Dt.13.11.2014**, 56/2014 dt. 21.11.2014 & 12/2015 13.03.15 for the financial year 2015-16 .
- (ii) The composition of the train will remain as 09 GSCN + 1 WCB +2 SLR till 29.02.16 .However, the train may be augmented by 3AC/SL coaches, if demanded by IRCTC for any particular trip(s).The composition will be increased by 2 GSCN coaches every 3 months, starting from 01.03.2016,till the composition reaches 18 coaches.
