(CASE No.C/ Container/Policy/0/RG)

Sub- Movement of Restricted Commodities in Containers.

Attention is invited to this Railway's R.C.(Goods) No. 59/2014 permitting movement of hydrated lime in container trains for a period of one year, which is valid till 30.06. 2015.

It has now been decided that loading of hydrated lime in container trains may be permitted for one more year, i.e. upto 30.06.2016. Zonal Railways shall closely watch the movement of Lime/Hydrated lime from their Railways to ascertain incremental quantity and earnings from movement of Hydrated lime.

FOIS/CRIS may capture loading of Hydrated lime in containers under separate code issued by Railway Board vide letter No.2013/Stat.V/83/2/Code dated 07.03.2013 for analysis in the future.

This issues with the concurrence of Traffic Commercial and Finance Directorate of Railway Board.
