In terms of Board's letter under ref(i) above, 5 posts of Pharmacist Gr.III (UR-2, OB-1, ST-2) were clubbed with RRB/Bilaspur and accordingly Panel was made ready and intimated to your office for collection of same vide ref (ii) above. However, RRB/GKP vide its letter under ref(iii) have now sent a revised indent reducing the number of post as 4 (UR-1, ST-2, OBC-1). Accordingly, provisional panel, as per your revised indent, is supplied to you. **Please note that the letter under ref (ii) was inadvertently dispatched and the same may be treated as "Cancelled".**

The candidates whose names appear in the enclosed provisional panel have been selected by Railway Recruitment Board, Bilaspur for appointment in your Railway. They may be given appointment in order of merit subject to

- (i) Their fitness in the prescribed Medical Examination.
(ii) Verification of their Character and Antecedents.

Before appointment, following points may be ensured/taken into consideration:

- The candidate has produced original certificates for educational/technical qualification, original caste certificate, proof of age etc, xerox copies of which have been submitted by the candidate at the time of document verification. This may be verified with the originals of the candidate reporting for appointment/medical examination.
- The candidates have filled their application "ONLINE" and during the Document verification they were made to fill up application format again same is made available in individual case files. The prints out of On-line applications have been taken and thumb impressions on the On-line application were not clear and hence the Finger Print Examiners have given remarks as UNFIT. They have been accepted after checking all other aspects such as thumb impression of the candidate obtained at the time of examination on OMR, attendance sheet, counterfoils etc., and the thumb impression of the candidate at the time of document verification.
- Thumb impressions of the candidate on the application form initially as well as obtained during document verification duly certified by Chief Finger Print Examiner/Sr. Finger Print Examiner with that of the candidate reporting for

appointment may be verified at your end. Wherever, the cases of unfit thumb impressions on On-line applications are mentioned, the thumb impression taken at the time of document verification on the application form may be taken into account for verification at your end. The unfit thumb impressions have been accepted as detailed above.

4. Wherever certain remarks have been mentioned against the names of the candidates in the enclosed list the same may be verified before issue of final appointment letter.
5. Some candidates have produced Provisional degree certificates/ provisional mark sheet of 10th/12th during document verification. Accordingly, they have been placed on the panel with remarks as "Subject to production of original 10th/12th Mark sheet/ original degree certificates". They should not be offered appointment unless they produce the original certificates for minimum educational/technical qualification required for the post or it is verified from the concerned School/College/University that they have indeed passed the 10th/12th/Degree for which Mark Sheets have been produced by them, if considered necessary.
6. Caste certificates may be verified from the Civil authorities at your end.
7. Documents & candidature verification may be done at your end also.
8. The candidate also fulfills all the conditions laid down in the indent in respect of educational/technical qualification, age, community etc.
9. In case, if any candidate is found debarred by any RRB or any discrepancies/irregularities detected, then his/her candidature may be cancelled after observing necessary formalities.




