NOTE:

1. In terms of Railway Board's letter No. 99/E (RRB)/26/6 dated 07.02.2000, it is advised that the above candidate/candidates has/have been empanelled provisionally and should not be offered appointment unless he/they produces Original Degree/Certificate, or it is verified from the concerned University/examining-body, that he/they has/have indeed passed the examination for which the marks-sheets have been submitted by them.

2. In terms of Railway Board's letter No. 2003-E (SCT)/71/2 dated 31.07.2003 (RBE No. 133/2003), the appointing authority, before appointing a person seeking appointment on the basis of reservation to OBCs, should verify the veracity of the community certificate submitted by the candidate and also the fact that he/she does not fall in creamy layer on the crucial date. The crucial date for this purpose may be treated as the closing date for receipt of applications i.e. 26.07.2015 for the post except in cases where crucial date is fixed otherwise. Authenticity of the caste certificate (SC/ST/OBC) may also be got verified from the issuing authority.

3. NB:- In terms of RRCB's Sl. No.8/2006, you are requested to intimate this office the name of the candidate against this panel who do not turn up after giving stipulated number of chances to join and whose candidature has been, accordingly, cancelled with the personal approval of Chief Personnel Officer.
