Sub: - Re- medical examination of A-one category staff declared unfit and De-categorized due to Diabetes Mellitus and associated complication.

Ref: - Board's letter of even No. dated 20.05.2011.

Attention is invited to Board's letter of even number dated 20.05.2011 wherein the decision of the Board to allow employees in A-one medical category who are suffering from Diabetes Mellitus to be declared fit for the respective category, if the Diabetes is controlled on diet and/ or on Tab. Metformin (oral hypoglycemic drugs) upto 2 gm/ day only was conveyed. It was further stipulated therein that the periodical medical examination of such employee is to be conducted every year in addition to regular follow up as per the advice of the treating physicians. This policy guideline had further stipulated that in service employees of A-one category who had been declared unfit due to Diabetes Mellitus prior to issue of Board's letter of even No dated 20.05.2011 will not be considered for re-medical examination.

The issue of debarment of in service employee of A- one categories who have been declared unfit due to Diabetes Mellitus prior to issue of Board's letter dated 20.05.2011 was taken up by both the recognized employees federations (AIRF & NFIR).


The matter has been re-examined in consultation with the user department viz. Electrical, Mechanical and Safety Directorates duly taking into account the views express by both the recognized employee federations. After detailed deliberation in the matter and discussion with the representative of the recognized employee federations, it has been decided to allow an appeal from employees de-categorized in the last two years immediately prior to the date of issue of initial order dated 20.05.2011 and relaxation in such cases to be considered on case to case basis subject to fulfilment of requisite mileages and successful completion of refresher courses and re-medical examination of the concerned employees in Aye one medical category with the rider that, the person suffering from Diabetes Mellitus can be declared fit in Aye one medical category if diabetes is controlled on diet and / or on Tab Metformin (oral hypoglycemic drug) upto 2gm only.

This issues in consultation with the Safety, Mechanical, Electrical and Establishment Directorates in Board's office. Accordingly an ACS to Annexure III (Para 509, 512) and 12.7.2 of IRMM-2000 is enclosed.

Other provisions contained in Board's letter of even No. 20.05.2011 will remain unchanged.



Annexure –III (Para 509,512) – 12.7.2 of IRMM-2000 to be replaced as under:-

Employees in A-one category who are suffering from Diabetes Mellitus can be declared fit for the respective categories if Diabetes is controlled on diet and / or on Tab. Metformin (Oral Hypoglycemic Drug) upto 2gm/day only.

It has also been decided to allow an appeal from employees de-categorized in the last two years immediately prior to the date of issue of initial order dated 20.05.2011 and relaxation in such cases to be considered on case to case basis subject to fulfilment of requisite mileages and successful completion of refresher courses and re-medical examination of the concerned employees in Aye one medical category with the rider that, the person suffering from Diabetes Mellitus can be declared fit in Aye one medical category if diabetes is controlled on diet and / or on Tab Metformin (oral hypoglycemic drug) upto 2gm only.

Periodic medical examination of such employee is to be conducted every year in addition to regular follow up as per the advice of the treating physician.
