Rates Circular (Goods) No 29 of 2017
(Case No. C/71/3/4/9/part-II/RG)

Sub- Rate Terminal charges to be collected by Port Trust Railway from customers.

Ref- This Railways Rates Circular(Goods) No.25 of 2015 and 21 of 2007.

- 1.0 In terms of this Railway Rates Circular(Goods) No.25 of 2015 , the rates for Terminal Charges to be collected by different Port Trust Railways for the period from 01.04.2015 to 31.03.2017 was conveyed to Zonal Railways.
- 2.0 The matter has been examined and it has been decided to revise the rates of Terminal Charges to be collected by Port Trust Railways of Mumbai, Kolkata, Chennai, Cochin, Paradip, Mormugao and Vishakhapatnam(for Vishakhapatnam in respect of traffic passing through north holding yard only), for the period 01.04.2017 to 31.03.2019 as Rs. 27.29 tonne for all type of traffic.
- 3.0 In respect of Vishakhapatnam Port Trust(Ore Exchange Yard) , Terminal Charge rate will be 80% of the rates indicated above.
- 4.0 The terms and condition notified vide Railway Rates Circular(Goods) 21 of 2007 in respect of collection and payment of Terminal Charges will continue to apply unchanged.
- 5.0 This issues with the concurrence of Finance Directorate of Ministry of Railways. All the circulars issued on and after 01.01.2014 are also available on this Railway website www.ner.indianrailways.gov.in and the circulars issued by Railway Board can also be downloaded on Railway Board's website www.indianrailways.gov.in.
