Rates Circular (Goods) No. 33 of 2017

(Case No. C/Congestion surcharge of Goods traffic policy/o/RG)

Sub: Congestion surcharge on Goods traffic originating from ports.
Ref- This Railway Rates circular(Goods)No. 36 of 2016 dt 27.4.2016.

1. Please refer to this Railways Rates circular(Goods) No. 36 of 2016 under reference whereby it was decided to withdraw the levy of Port Congestion Surcharge @ 10% on Base Freight Rate on all goods traffic, including Containers traffic, originating from Ports. These instructions are valid upto **31.3.2017**.
2. The matter has been reviewed and the competent authority has decided that these instructions shall be extended **beyond 31.03.2017** for a further period of one year i.e. upto 31.03.2018.
3. **Port serving Division shall furnish quarterly report regarding traffic originating from Ports so that the policy can be reviewed after six months i.e. after 30.09.2017.**
4. **This issues in consultation with Traffic Transportation Directorate and with the concurrence of the Finance Directorate of Ministry of Railways.**
