Refer Railway Board's letter No. 2012/TT-III/73/9 Vol.II dated 30.06.2017 for movement of EXIM Container trains under Hub & Spoke Policy. The validity of Container Train Circular No.07/2017 was for the period of Six months only i.e. upto 31<sup>st</sup> Dec. 2017.

Now as it is necessary to do so in the public interest, the validity of this container train circular is hereby extended further for a period of One Year from the expiry date i.e. from 1<sup>st</sup> Jan, 2018 to 31<sup>st</sup> Dec, 2018 unless modified / cancelled earlier.

A detailed review may further be conducted on Six monthly basis by Zonal Railway about trends of traffic on the said sectors for taking a holistic view and decision in the matter.
