1. The lien of the transferred staff will be continued to be maintained in the parent Railways till closure of the cadre and accordingly all promotional aspects will progress there.
2. The last date of submission of option is 29/06/2018. No option will be entertained after this date.
3. The administration will have the right to short list the candidates after screening as per its own requirement of the working knowledge and experience of the staff. Hence, merely option will not confer any right on them for automatic transfer.
4. Screening of applications will be conducted immediately after the cut-off date and acceptance will be issued as per policy guidelines outlined by this administration until desired vacancies are filled up.
5. If an employee is working on ex-cadre post in any organization such as RE, Construction, CAMTECH etc, their application should be forwarded through personal department of his parent Railway.
6. Staff whose options are accepted would not normally be returned on administrative account unless there is serious reason of misconduct etc.
7. The option form should be routed through the Personnel Department with photocopy of service/leave record along with photocopy of APAR. No advance copy will be entertained.

It is hereby requested to please circulate to all concerned units under your control invitation options from willing staff and same to be forwarded to this office by 20/06/2018 as per above procedure. It should be ensured that the option once exercised by the willing staff and acceptance issued by this Railway will be treated as final and staff will have to be released without fail so that posting of the staff be immediately ensured for TRD organization in the Electrical Department of Varanasi Division (N.E.Railway).
