Sub:- Re-engagement of retired railway Employee on Monthly remuneration basis in Signal & Telecommunication Department.

The Under mentioned retired railway employees found eligible for Re-engagement on monthly remuneration basis as per guidelines of Railway Board in S&T Department on Varanasi Division with effect from 20.04.2018 on term and condition mentioned below:-

All the above named Retired Railway Employees are Re-engaged up to 01.12.2019 or attending of 65 Yrs age of availability of direct recruitment or promotional quota whichever is earlier. Administration is at liberty to terminate their services of Re-engagement in case their Work/Conduct is found unsatisfactory by giving a notice of 07 days of the conditions stipulated on reverse side. This has the approval of competent authority. Pleasure report their arrival to all concerned immediately.

Term and Conditions of Re-engagement:-

1. This Re-engagement is to be reviewed at the interval of every year effective from 1st January of the year.
2. The administration is at liberty to terminate the services of the re-engaged employees even before 01.12.2019 in case their work/conduct if found unsatisfactory by giving a notice of 07 days.
3. The re-engaged employee are entitled only monthly fixed remuneration i.e. reducing person form his/her last pay drawn(i.e Basic+DA as applicable) at the time of retirement. The monthly fixed remuneration plus pension shall not exceed the last pay drawn at the time of retirement.
4. The re-engagement employee will not be eligible for any kind of leave (like CL, LAP and Sick Leave etc.) for absent, if any appropriate deduction will be made from the monthly remuneration.
5. The duty hours of the re-engaged employee would be as per with regular staff/requirement. The duty hours can be changed as per the requirement of work by the administration.
6. The re-engaged staff will not have any claim or right for his continuity in service of automatic extension of termination of contract.
7. The service condition of re-engaged retired employees will be governed by Railway Board guidelines issued from time to time.
8. Re-engaged staff should be discharged immediately on joining of selected candidates.
9. Respective in charge will submit monthly report Sr.DSTE through ADSTE regarding their working.
10. Respective in charge will keep close watch on their day to day working.
