Term and Conditions of Re-engagement

1. This re-engagement is to be reviewed at the interval of every year effective from 1st January of the year.
2. The scheme is valid up to 01/12.2019.
3. The administration is at liberty to terminate the services of the re-engaged employees even before 01.12.2019 in case their work/conduct is found unsatisfactory by giving a notice of 07 years.
4. The re-engaged employees are entitled only to monthly fixed remuneration i.e. reducing person from his/her last pay drawn (i.e. Basic+DA as applicable) at the time of retirement. The monthly fixed remuneration plus pension shall not exceed the last pay drawn at time of retirement.
5. The re-engagement employee will not be eligible for any kind of leave (like CL, LAP and sick Leave etc.) for absent, if any appropriate deduction will be made from the monthly remuneration.
6. The duty hours of the re-engaged employee would be as per with regular staff/requirement. The duty hours can be changed as per the requirement of work by the administration.
7. The re-engaged staff will not have any claim or right for his continuity in service of automatic extension of termination of contract.
8. The service condition of re-engaged retired employees will be governed by Railway Board guidelines issued from time to time.
9. Re-engaged staff should be discharged immediately on joining of selected candidates.
10. Respective incharge will submit monthly report to Sr DCM through DCM regarding their working.
11. Respective incharge will keep close watch on their day to day working.


