
**Sub.: Model Schedule of Powers (SOP) – 2018: Implementation on NE Railway**

**Ref.: ED/Transformation, Railway Board's Letters No.2018/Trans/01/Policy  
dt.24.07.2018 & dt.26.07.2018**

Railway Board, vide above referred letter dt.24.07.2018 (issued with concurrence of Associate Finance of Transformation Cell of Rly. Board), have circulated a Model Schedule of Power (SOP)-2018, superceding Model SOP-2017 issued by Railway Board in October 2017, which was implemented on NE Railway vide letter dt.31.10.2017. This Model SOP -2018 stands implemented on NE Railway, **with immediate effect** as under:

- (i) This Model SOP-2018 shall supercede existing Model SOP-2017 implemented on NE Railway vide letter No.Z/548/Model SOP/2017 dt.31.10.2017.
- (ii) In terms of "**Preface to Model SOP-2018**", GMs are authorized to add further to this delegation in consultation with PFA, keeping in view the local requirements while being within the overarching powers delegated to them and in accordance with Government of India rules. Accordingly, wherever it is considered that delegations existing in this Model SOP-2018 require any enhancement/modification, the same may be proposed by concerned PHODs / DRMs, with full justification after PFA's concurrence to DGM/G for approval of General Manager
- (iii) Instructions issued by Railway Board with the approval of Competent Authority inter-alia including process reforms & empowerments, will get implemented with immediate effect from date of issue of the instructions, unless otherwise specified. In case the instructions involve modification in Schedule of Power of NE Railway, the instructions may take effect without waiting for a formal Correction Slip. Correction Slip will be issued thereafter (Auth.: ED/Trans., RB's L/No.2018/Trans/01/Policy dt.26.07.2018).
- (iv) Model SOP-2018 is being uploaded on NER's website ([www.ner.indianrailways.gov.in](http://www.ner.indianrailways.gov.in)) from where all concerned may download it for their use.
