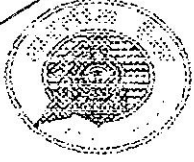

Sub:- Revision of designations of erstwhile Group 'C' Nursing staff



Discussion with both Staff Federations (AIRF & NFIR) have also been held in the matter. Accordingly, it has now been decided to revise the designations of Group 'C' Nursing staff as under:-

Existing designation	Level as per pay Matrix	Revised designation
Staff Nurse	Level-7	Nursing Superintendent
Nursing Sister	Level-8	Senior Nursing Superintendent
Chief Matron	Level-10	Chief Nursing Superintendent

The revised designation as mentioned above, will not entail any change in the pay scale, duties & responsibilities, mode of recruitment, level of supervision, selection procedure, eligibility conditions prescribed for the posts or in the avenue of promotion. The percentage distribution of posts will also remain unchanged by the revision of the above designations.
