NOTIFICATION

Sub: Re-engagement of Retired staff in exigencies of services in Accounts office,
N.E.R., Izatnagar Division.

In terms of Railway Board's letter no. E(NG)II/2007/RC-4/CORE/1 dated 16-10-2017 & 12-12-2017, it has been decided to fill up the following vacancies in Accounts office by re-engagement of staff who have retired from Indian Railways.

Therefore application of staff who have retired from Railway service are called for to reach Accounts department, Izatnagar division on or before 30-10-2018.

The following terms and conditions may kindly be noted:-

(1) The re-engagement shall be for one year and further extendable each year upto attaining the age of 65 years or till the availability of regular candidates, whichever is earlier.

(2) The administration is at liberty to terminate the services of the re-engaged employees at any time & stage even before one year in case their work/conduct is found unsatisfactory.

(3) The employees Removed/Dismissed/Compulsory retired as a result of disciplinary action or in review, are not eligible for re-engagement. Further, employees retired under SRRS/ LARGESS will not be eligible.

(4) The re-engaged employees are entitled only for monthly fixed remuneration i.e. reducing pension from his/her last pay drawn (i.e. Basic+DA) at the time of retirement. The monthly fixed remuneration plus full pension shall not exceed the last pay drawn at the time of retirement. No other remuneratin/ allowance will be payable.

(5) The re-engaged employees will not be eligible for any kind of leave (like CL, LAP, Sick leave etc.). For absence if any proportionate deduction will be made from the monthly remuneration.

(6) The re-engaged employees are not entitled for any other benefit or facilities except the monthly fixed remuneration.

(7) The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.

(8) Re-engaged shall be subject to prescribed medical fitness for the relevant category. c/17

(9) Suitability/competency of the applicant shall be adjudged by nominated committee before their engagement.

(10) Re-engagement employees under supervisory category will also do any work assigned to them.

(11) Copy of any of the following documents should be attached with the application & it is Mandatory.

- (a) Service certificate
- (b) pensioner Identity Card
- (c) Pension Payment Order
- (d) Other relevant papers as and when required.

(12) The last date of submission of application is 30-10-2018 Staff retired employees from Railways desirous for re-engagement, have to submit their application in the prescribed format at Annexure A in Accounts Office, NER, Izatnagar Division on or before 30-10-2018.

(13) Employees re-engagement may be posted at any office/station under the jurisdiction of Sr.DFM/IZN.


(14) All re-engagement employees shall be governed by the railway rules, provisions, guidelines etc. Issued by Railways/Railway Board/HQ/Division. Any variation/violation will lead to termination of contract of service.

(15) No claim/exdplanation will be acceptable and the decision of Railways will be final.

(16) No preconditions from candidates will be entertained and application will be summarily rejected.

(17) Format of application is attached as Annexure 'A'.
