Contents of Board's Letter No.TC-I/2018/104/2 Pt. C dtd. 04.12.2019. (Addendum to Rates Circular No. 05 of 2019) is reproduced below for information & compliance.

"Please refer to Para 4.2 under head 'Base freight rate and commodity class applicability' of Rates Circular No.05 of 2019 under reference.

The matter has been reviewed and it has been decided to insert following provision by adding para 4.2.3 as under:

4.2.3 Railways shall accord priority in allocation of rakes within same class to freight customers who have signed agreement under Freight Advance scheme as per the instructions issued under Preferential Traffic Order (PTO) by Traffic Transportation Directorate of Railway Board from time to time.

All other rules shall remain unchanged.

This issues in consultation with Traffic Transportation Dte. and with the concurrence of Finance Dte. of Ministry of Railways."

These instructions are already circulated vide this office letter of even number dtd. 05/12/2019.
