- 1.0 In terms of Board's letter referred at (i) above, Southern Railway have forwarded proposal with due approval of the General Manager to include the route Irugur – Coimbatore North – Podanur Section (IGU – CBF – PTJ) Up and Down lines of Salem Division of Southern Railway in the CC+8 routes.

- 4.0 These instructions shall come into effect from 22.02.2020 and shall remain valid till further advice.
