Sub: Charging of 'Export Traffic to Bangladesh' booked in Indented Parcel Rakes (consisting of Parcel Vans).

Ref: CCM/FS/SCR letters No. C.423/Mktg./CPLP-Vol III (Pt.)/2020 dated 09.07.2020 & 14.07.2020.


In reference to above letter, Ministry of Railways has decided that the Export Traffic to Bangladesh, booked in Indented Parcel rakes (consisting of Parcel Vans) shall be charged as per the principles as under:

1. Charging of Parcel Rakes shall be as per actual number of Parcel vans in the Parcel Rakes subject to minimum 'twenty (20) Parcel Vans plus one Brake-van'.
2. **Base Freight** shall be charged at 'P-scale' as per the actual distance and Carrying Capacity.
3. **Congestion Charges** shall be charged at 25% of the Base Freight.
4. **Development Charges** as applicable.
5. **Custom Clearance Charges @Rs.17/- per Tonne, plus GST as applicable.**
6. GST (as applicable) on Total Charges.

Action may be ensured accordingly, under confirmation to Board.

This issues in consultation with Traffic Transportation and Coaching Directorates, and with the concurrence of Finance Directorate of Ministry of Railways.




