

Ref: Rates Master Circular/CRT-CCR-Hub&Spoke/2015/0 and its corrigendum No.30
dt.06.09.2019

Please refer to Corrigendum No.30 dt.06.09.2019 of Rates Master Circular under reference vide which guidelines for round trip basis charging in case of ultra short lead (upto 50Kms) container traffic (either EXIM or Domestic or both) which are moving at Haulage Charge per TEU basis, have been implemented w.e.f.15.09.2019. These guidelines are valid upto 14.09.2020.

The matter has been reviewed and it has been decided to extend the above instructions beyond 14.09.2020 upto 30.04.2021.

This issues in consultation with Traffic Transportation Dte. and with the concurrence of Finance Dte. of Ministry of Railways.
