Sub: Classification of Viscose Staple Fibre (VSF) in the Goods Tariff No.49 Pt.I, Vol.II.


Ref: Rates Circular No.22 of 2020 dt. 21.9.2020

This issues in consultation with Traffic Transportation and with the concurrence of Finance Directorate on Ministry of Railways.




