


1. In terms of Board's letter No. TCR/1017/2016/01/Pt. dated 15.04.2020 (Corrigendum No.30 to RMC/2016), minimum composition of BCNHL rake was reduced from 57 to 42 wagons for grant of trainload rate benefit. These instructions are valid till 30.09.2020.
2. The matter has been reviewed and the Competent Authority have decided to extend the validity of the aforesaid instructions up to 31.12.2020.
3. All other terms and conditions prescribed in the above referred Rates Master Circular and Corrigenda thereto shall remain unchanged.
4. This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.
