

Sub: Two/multiple unloading points for Automobile traffic (other than that loaded in rakes owned by AFTOs, and DBKMs).

Ref: Rates Circular No. 19 of 2020.


1. Reference above, Board had decided to introduce two/multi point destination for Automobile Traffic, when loaded in NMG, BCCNR, BCACM or any other similar type of wagons (other than that loaded in rakes owned by AFTOs, and DBKMs). In terms of condition stipulated vide 1.(iv) thereof the maximum distance for two continuous destination (unloading) points for Automobile traffic have been notified as 500 kms.
2. The matter has been reviewed, and the Competent Authority have decided, as a special case, to allow **CHANGSARI/ NF Railway** and **JIRANIA/NF Railway** as an approved combination for unloading of Automobiles in NMG rakes.
3. All other terms and conditions prescribed in the above referred Rates Circular shall remain unchanged.
4. This instruction shall come into force w.e.f. 16.10.2020 and shall remain valid for a period of one year i.e. up to 15.10.2021.
5. This issues in consultation with Freight Marketing, Traffic Transportation Directorates and with the concurrence of Finance Directorate of Ministry of Railways.




