### **Appeal against the decision of Divisional Medical Board/Committee Under GDCE-2018**

(Ref.: Employment Notice No.-NER/RRC/GDCE/2018 Dated 21.06.2018)

After Document Verification Under GDCE-2018 conducted by Railway Recruitment Cell/North Eastern Railway/Gorakhpur on various dates, candidates were sent for Medical Examination to Railway Hospitals at Gorakhpur, Varanasi, Badshahnagar and Izzatnagar. As per Medical reports received from concerning Railway Hospital, some of the Candidates were found unfit in required medical category and they could not be empanelled against GDCE-2018.

However, if the candidate is not satisfied with their above medical report and wish to appeal for their re-medical examination, such candidates can submit their appeal as per provisions contained in Railway Board's Letter No.-2014/H/5/8(Policy) Dated 07/07/2017 with in a period of 30 days from this notice.

The appeal should be sent to **Chairman, Railway Recruitment Cell, North Eastern Railway CCM Annexe Building Rly. Road No-14 Gorakhpur-273012** and should reach latest by 18.00 hrs. on 10.12.2020 by speed post/person on any working day. **No further chance will be given for Medical Examination.**

Such an appeal shall be entertained, only if:

- The candidate produces a certificate from a Government/Private Doctor of the specialist in which the candidate has been found unfit.
- Such certificate should contain a note that the Government/Private specialist is fully aware of the physical & visual standards set by the Railway for the particular medical category, and that he is aware of the fact that the candidate has already been declared unfit according to these standards during medical examination conducted by an appropriate Medical Board comprising of three senior Railway Doctors appointed by the Government in this regard (Certificate should be as per enclosed Proforma "A")
- The certificates should bear the photograph and mark of identification of the candidates duly attested by such a Government/Private Doctor, the issuing authority.
- Such an issuing authority shall also clearly mention its MCI/State Registration Number.
- Charges will however be payable by candidate and towards this end, a candidate will be required to pay Rs.1000/-(One thousand) through Demand Draft payable in favor of **P.F.A, North Eastern Railway, Gorakhpur.**

The decision of PCMD N.E. Railway, whether the appeal of the candidates should be considered for re-examination or not, will be final and binding on the candidates. Where PCMD is of the opinion that there should be re-examination of the case of appeal, he may nominate a Medical Board to re-examine the candidate. The recommendations of Medical Board duly approved by PCMD will be communicated to the candidate through RRC/Gorakhpur.

In case, the decision changes to Fit in relevant medical category from Unfit, the Demand Draft submitted to railway will be returned to the candidate. In all other cases, this Demand Draft will be credited to Railway Revenue.
