

Engagement of retired employees had been allowed on Railways vide Board's letter 28.11.2019 referred to above. Instructions were also issued vide Board's letter dated 10.07.2020 to review services of all such employees.

The matter has since been reviewed further. It has been decided that no retired employees should be re-engaged following expiry of this Scheme on 02.12.2020. These instructions do not apply to staff engaged in para-medical category which has been allowed upto 31.12.2020 vide Board's letter No. No. E(NG)H/2005/RC-4 SC.2 Pt.1 dated 01.07.2020
