
Sub: Haulage Charge for movement of Cube Containers
Ref: (i) Rates Circular No.20 of 2018 and its amendments
(ii) Rates Master Circular/CRT-CCR-Hub&Spoke/2015/0 and its amendments

Reference has been received regarding levy of Haulage Charge for movement of Cube containers by CTOs.

The matter has been examined and competent authority has decided that Haulage Charge for cube container(s) loaded on a container wagon (BLC etc.) will be levied at par with the notified Haulage Charge for 40 feet container in 'weight slab 10T-20T', irrespective of the fact whether the wagon is fully loaded or partially loaded with cube container. At present, Haulage Charge for 40 feet container is 1.8 times of Haulage Charge per TEU.

Discount currently permitted for loaded containers and/or empty flats/empty wagons will not be allowed in the case of rake loaded with cube containers. Further, notified commodities are not allowed to move in cube containers.

This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.








