Sub: Addendum to Para 4.5 of Private Siding Policy issued vide FM Circular No. 11 of 2016 dated 22.08.2020 - Amendment No. 7

Ref: Freight Marketing Circular No. 11 of 2016 issued vide letter No. 99/TC(FM)/26/1/Pt.-II dated 22.08.2016

It has been decided to incorporate the provision of revival of private siding proposals closed due to being non-responsive by adding sub-para 4.5 (iii). Accordingly, Para 4.5 of the above referred circular may be read as under.

1. **Para 4.5 – Extension, closure and revival of proposals:**

(iii) All such siding proposals closed under (i) and (ii) above, for which the request for revival is received within three (03) years of such closure, may be revived with the approval of General Manager. Codal charges already paid by the applicant may be adjusted as under:

a) All such cases where the cost of siding has increased during the intervening period, the differential amount towards codal charges shall be collected from the applicant.

b) All such cases where cost of siding has decreased during the intervening period, differential amount towards codal charges shall not be refunded or adjusted.

2. Party shall submit the proposal for revival to the concerned DRM, on receipt of which 'Divisional Committee on Siding' shall forward the recommendation to CTPM with the approval of DRM. CTPM shall process for obtaining the approval of General Manager through Zonal Committee.

3. This provision shall also be applicable on the proposals which have been closed prior to the issue of this Circular.

4. This issues in consultation with Civil Engineering Directorate and with the concurrence of Finance Directorate of Ministry of Railways.
