Sub:	Classification of Petroleum Coke- Segregation from Main Commodity Head "Coal and Coke"
Ref:	i. IRCA Goods Tariff No.49 Pt.I Vol.II ii. Rates Circular no.26 of 2020.

1. In terms of Rates Circular No.26 of 2020, the main commodity head 'Coal and Coke' was bifurcated into 'Petroleum Coke' and 'Coal and Coke, other than Petroleum Coke'. Also, Petroleum Coke was made eligible for STS concession.
2. In this regard it is clarified that the Classification of Petroleum coke is available till further advice, and, eligibility of STS concession is subject to validity of the STS scheme. It may, however, be ensured that grant of discount on traffic should not lead to loss of net revenue.
3. All other details of the Rates Circular under reference shall continue to apply unchanged.
4. This issues with the concurrence of Finance Directorate of Ministry of Railways.
