**Sub: Rate of Stabling Charge**

Ref: (i) Rates Master Circular/Demurrage-Wharfage-Waiver/2016/0 and its Corrigendum No.8  
(ii) Board's letter No.TC-I/2019/201/6 dated 23.11.2020

Please refer to Corrigendum No.8 of Rates Master Circular/Demurrage-Wharfage-Waiver/2016/0 stipulating the rate of Stabling Charge as Rs.525/- per wagon per day or part of a day. These guidelines are valid upto 31.03.2021.

In terms of Board's letter under reference (ii), no Stabling Charge is leviable in case of container traffic during 18.05.2020 to 31.03.2021.

The matter has been reviewed and it has been decided that the rate of Stabling Charge in case of all privately owned wagons including wagons owned by container operators will be Rs.525/- per wagon per day or part of a day, w.e.f. 01.04.2021 till 31.03.2022.

This issues in consultation with Traffic Transportation directorate and with the concurrence of Finance directorate of Railway Board.
