

Sub : Haulage Charge for movement of RoadRailer type 'BAFRDR'.
Ref : Freight Marketing Circulars Nos. 21 of 2019 dated 05.08.2019 (and its subsequent corrigendum dated 14.08.2019), 29 of 2019 dated 23.12.2019 and 15 of 2020 dated 31.08.2020.

1. In terms of Freight Marketing Circular No. 29 of 2019 dated 23.12.2019, the Haulage Charges for movement of RoadRailer type 'BAFRDR' were revised and notified for the period from 23.12.2019 to 21.09.2020. The currency of this circular was extended for the period upto 31.03.2021 vide Freight Marketing Circular No. 15 of 2020 dated 31.08.2020.
2. The matter has been reviewed by Board and sanction is accorded to extend the currency of present haulage charges for movement of RoadRailer type 'BAFRDR' further from 01.04.2021 to 31.07.2021.
3. All other terms and conditions mentioned in above referred Freight Marketing Circular shall remain the same.
4. This issues in consultation with Rates Directorate, and with the concurrence of Finance Directorate of the Ministry of Railways.
