In terms of Corrigendum dt.16.10.2020 of Rates Circular No.32 of 2014, following relaxation for charging Military Special Train is valid upto 31.03.2021.

Para	Guidelines as per RC 32 of 2014	Revised Guidelines as per Corrigendum dt.16.10.2020
2.4	Charge for coaching train shall be levied for actual number of coaches in the train subject to a minimum charge for 18 coaches per train.	Charge for coaching train shall be levied for actual number of coaches in the train subject to a minimum charge for 10 coaches per train. This relaxation will be applicable till 31.03.2021 and post which, the charge for coaching train shall be levied for actual number of coaches in the train subject to a minimum charge for 18 coaches per train.

The matter has been reviewed and it has been decided to extend the currency of above-mentioned relaxation beyond 31.03.2021 for a further period of one year i.e. upto 31.03.2022.

This issues with the concurrence of Finance Directorate of Ministry of Railways.


