**Sub:** Rates for automobile traffic when carried on NMG, BCCNR, BCACM wagons.

**Ref:** Rates Circular No. 24 of 2019 and its corrigenda in continuation to Rates Circular No. 11 of 2018, 22 of 2018, 17 of 2017 and 19 of 2016.

1. Board had notified charging for Automobile Traffic, when loaded in NMG, BCCNR, BCACM Wagons. The validity of the extant rates is up to 30.11.2021 in terms of Corrigenda No.1 to Rates Circular No. 24 of 2019.
2. The matter has been reviewed and the Competent Authority has decided to permit movement of NMG rake wherein along with Motor Vehicles, some wagons are loaded with Spare Parts or Other Machinery; some with Lubricating Oil like Grease, then charging will be as under:

Commodity	Charged at
Motor Vehicles	NMG freight rate per wagon basis
Spare Parts or Other Machinery	Applicable trainload class rates as per Goods Tariff
Lubricating Oil like Grease etc.	Applicable trainload class rates as per Goods Tariff

3. Commodities other than Motor Vehicles are allowed to be carried in NMG wagons are subject to the condition that the commodities must be duly packed in such a way that it shall not harm the wagon during transportation.
4. This issues in consultation with Traffic Transportation Freight Marketing Directorates and with the concurrence of Finance Directorate of Ministry of Railways.
