Ref: Railway Board's Freight Marketing Circulars No. 04 of 2021 dated 02.03.2021

In partial modification to FM circular no. 04 of 2021 dated 02.03.2021, Ministry of Railways desire that the charges notified for distances 1001 Km and above (₹0.51 per berth per Km subject to minimum realization of haulage charges applicable on distance of 1000 Km. subject to minimum of ₹610/-) shall be read as under:-

“₹0.50 per berth per Km subject to minimum realization of haulage charges applicable on distance of 1000 Km. subject to minimum of ₹610/-“
