**Sub: Movement of Liquid Medical Oxygen (LMO) in container train – no Haulage Charge for Dummy container (empty container)**

Ref: (i) Rates Master Circular/CRT-CCR/Hub&Spoke/2015/0 and its corrigenda

A clarification has been sought regarding charging of dummy container due to operational/safety point of view in LMO container rake.

The matter has been examined. In continuation to Corrigendum No.3 dated 25.04.2021 to Rates Circular No.16 of 2021, it is clarified that dummy container (i.e. empty container) loaded in LMO container rake on account of operational/safety consideration shall be exempted from levy of Haulage Charge.

This issues in consultation with Traffic Transportation Directorate and concurrence, vide Note#59 Computer#3351947, of Finance Directorate of Ministry of Railways.
