
Sub : Inflation in distance for charging freight on Banspani-Tomka section.

Ref.: Railway Board's Rates Circular No.14 of 2007; 06 of 2012; 14 of 2012; 16 of 2015; and 10 of 2018.

In continuation of Rates Circulars referred above, sanction of the Competent Authority is hereby accorded to extend the currency of instructions to inflate the distance for charge by 30% (thirty percent) for the purpose of charging freight on the Banspani-Tomka section on East Coast Railway and South Eastern Railway beyond 31.05.2021 for a period of four years i.e. 31.05.2025.

This inflation shall apply uniformly for all description of goods traffic.

This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate (vide Note#10-12 Computer No. 3350880) of Ministry of Railways.



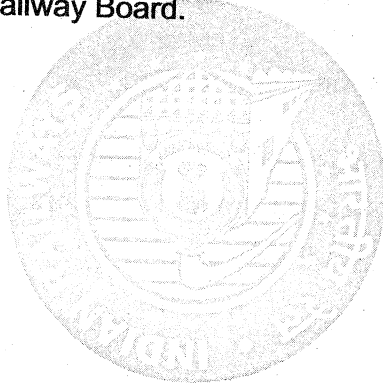
