Rates Circular No.27 of 2016 and Corrigenda thereto.**

In terms of Rates Master Circular on Block Rakes/Mini Rake/Two Point Combination
etc./2020 and corrigenda thereto, policy on Two Point Combination for covered wagons
and other than covered wagons (for steel traffic only) has been notified.

The matter has been reviewed and the Competent Authority have decided to allow two
point combination for loading of Bentonite in jumbo bags in open wagons as under:
