

Please refer to Corrigendum No. 17 to Rates Master Circular on Block Rakes/Mini Rake/Two Point Combination etc./2020 dated 19.03.2021. This Corrigendum has mention of the Permissible Carrying Capacity and Loading Tolerance of BAFRDR, which were notified in terms of Corrigendum No. 4 to Rates Master Circular/PCC/2019/0 w.e.f. 10.06.2019 till further advice. And also has mention of the Standard Rake Size and minimum number of wagons to be loaded of BAFRDR with validity period from 01.04.2021 till 31.07.2021.

The matter has been reviewed and the Competent Authority has decided to extend the guidelines regarding standard rake size and minimum number of wagons to be loaded of BAFRDR wagons beyond 31.07.2021 till 31.03.2022.

The Rates Master Circular under reference should be modified accordingly. All other details shall remain the same.

This issues in consultation with Freight Marketing and with the concurrence of Finance Directorate of Ministry of Railways.


