**Sub: Running of freight trains on CC+8 routes.**

**Ref: (i) Board's letter No.2018/E&R/1(8)/4 dated 24.04.2018.  
(ii) Rates Master Circular/PCC/CC+8 etc./2020/0 dated 01.05.2020.**

1. Please refer to Annexure III to Rates Master Circular under reference at (ii) above, wherein list of CC+8 routes is prescribed.
2. In terms of reference (i) above, General Manager are empowered to approve running of CC+8 operation. Other conditions and procedures remain same.
3. Northern Railway has forwarded proposal with due approval of General Manager to include  
**Chandigarh(CDG)-Morinda(NMDA)-Sanehwal(SNL); and  
Bathinda(BTI)-Sriganganagar(SGNER) routes in the list of already identified  
CC+8 routes.**
4. Now, sanction of the Competent Authority is hereby accorded to include above referred routes of Northern Railway in the list of already identified CC+8 routes.
5. Accordingly, Annexure-III of Rates Master Circular under reference (ii) above shall be modified.
6. All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
7. These instructions shall come into effect from 08.09.2021 and shall remain valid till further advice.




