**Sub: Haulage Charge for running of Double Stack Dwarf Container**



The matter has been reviewed and it has been decided to extend the currency of extant instructions regarding Haulage Charge for running of Double Stack Dwarf Container for a further period of one year beyond 31.03.2022 i.e. upto 31.03.2023.

This issues in consultation with Traffic Transportation directorate and with the concurrence of Finance directorate of Railway Board.


