In the subject matter quoted under reference, a fresh Concession Agreement has been executed between Northern Railway Administration (CCM/R&M/NR) and J M Baxi Port & Logistics Limited on 2.03.2022 for Operation of Container Trains on Indian Railway network after change the name in the Concession Agreement from International Cargo terminals and Infrastructure Private Limited.

It is to informed that on 04.01.2007 concession agreement was executed between Railway Administration and Boxtrans Logistics (India) Service Pvt. Ltd. (Category-III) for a period of 20 years which was further transfer to International Cargo Terminals & Rail Infrastructure Pvt. Ltd. on 07.01.2016. The said Agreement further was again transferred to International Cargo Terminals & Infrastructure Pvt. Ltd. on 27.06.2018).

As per clause para 3.6.1, this fresh concession agreement is pursuant to change/transfer of concession Agreement by J M Baxi Port & Logistics Limited (Category - III) and the agreement will be valid with J M Baxi Port & Logistics Limited only for the remaining period i.e. 03.01.2027.
