In terms of Corrigendum No.21 and Corrigendum No.22 of Rates Master Circular under reference, additional free time for cleaning activities (cleaning, mopping, coating and drying) of tank wagons is permitted in private siding(s) and Goods shed in case of edible oil when there is change of product. These guidelines are valid upto 31.03.2022.

The matter has been reviewed and it has been decided to extend the validity of above mentioned guidelines beyond 31.03.2022 for a period of one year i.e. upto 31.03.2023.

Zonal Railways will carry out an actual time & motion study for cleaning activities of tank wagons and may furnish their report by 31.12.2022.
