Sub: Rate of 'Haulage Charge per TEU' for movement of 42feet containers in privately owned wagons

Ref: Corrigendum No.11 to Rates Circular No.20 of 2018


In terms of Corrigendum No.11 to Rates Circular No.20 of 2018, Haulage Charge in case of 22 feet, 24 feet and 25 feet container is at par with 20 feet container(TEU) and Haulage Charge in case of 45 feet container is at par with 40 feet container(FEU).

The matter has been reviewed and it has been decided that in case of 42feet container, Haulage Charge will be levied at par with 40feet container(FEU).

Accordingly, Rates Circular No.20 of 2018 stands modified.

These instructions will come into force w.e.f.26.05.2022 and will remain in operation till further advice.

This issue in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.




