

**NORTH EASTERN RAILWAY
RATES CIRCULAR (Goods) No. 84 of 2022
(CASE NO. – NER-HQ0COMM(RAT)/42/2020-O/o PCCM/HQ/NER)**

Sub:-Opening of Gonda Kachahri (GDK) and Chauri Chaura (CC) of Lucknow(LJN) Division as Two Point Combination (Originating Point) for outward traffic .

The Competent authority has decided to open Gonda Kachahri (GDK) and Chauri Chaura (CC) Goods shed of Lucknow (LJN) division as Two Point Combination (Originating Point) for outward traffic .

It is advised that in terms of corrigendum No.11 to RMC on block rakes/mini rake/two point combination etc/2020 dated 24.12.2020, the condition that the two point rakes shall be freely allowed if the two points originating/destination are up to 200 km apart, beyond 200 kms up to 500 kms, two point rakes shall be allowed subject to levy of supplementary charge @ 5% and validity of instructions contained in this corrigendum and extension issued thereafter.

Subject to the condition that all safety measures must be ensured, subject to Condition mentioned in para 8.0 of Rates Master Circular on Block Rake/Mini Rake/Two Point combination etc./2020 issued vide Railway Board's Letter Number TCR/1017/2020/03 dated 02.07.2020 Circulated vide this Railway's Rates Circular (Goods) No. 95 of 2020 dated 02.07.2020 and Para 2.1 of Rates Circular No. 63 of 2005 issued vide Railway Board's Letter No. TCR/1017/2001/9 dated 25.10.2005.

Staff Concerned to please note and act accordingly.

DRMs to be please ensure compliance by the staff.
